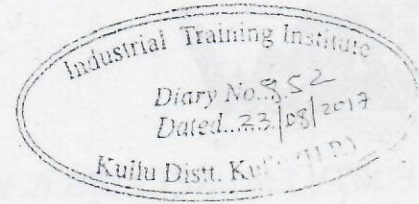

**Areas of co-operation:**

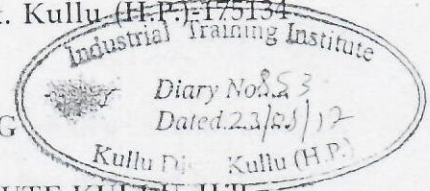
1. To facilitate industrial visit for trainees of the institute to hydro power projects.
